1281.1 Cursey Lane. Councillor McLain assured the Parish Council that the resurfacing work was going to take place although the timescale could not be confirmed.

1282.1. To date no action has been taken and the Clerk will chase highways.

## 1283 To update action regarding Fly Tipping.

1283.1 The Parish Council were informed that this had been reported by a local resident.

# 1284 To consider the burning nuisance at 'The Barn' by J10.

1284.1 The Parish Council recommended that the next time this happened, it should be reported as a nuisance and the police informed.

## 1285 To receive an update regarding J10 M5.

- 1285.1. The Parish Council was addressed by Adam Bunce from the M5 J10 team
- 1285.2 The Scheme was submitted at the end of last year to the Planning Inspectorate at Central Government Level. The Scheme is currently in the pre examination phase and the start of the process commences on the 4/6/24 which will take about 6 months whereupon the Planning Inspectorate will give a recommendation to the Secretary of State. The final decision is expected Spring/Summer 2025.
- 1285.3 It is anticipated that construction will start towards the end of 2025 taking about 2/3 years with a lot of the work being done off the public highway with a link road being built through existing fields. He thought the impact on the locality would be fairly limited. Any restrictions to the highways would be mitigated by the use of temporary traffic lights and overnight closures.
- 1285.4 They are looking at concerns regarding the safety at the Old Spot junction but they are looking to create a major junction using a signalised roundabout as opposed the current

flier road where vehicles can travel at speed, Intelligent signalling will reduce the risk of queues forming. Also issues were raised about large vehicles turning left at the junction. Adam said that we would look at the options to make space at the junction to mitigate traffic queues.

- 1285.5 They expect an increase in traffic through Stoke Orchard but they are designing a mitigation scheme to discourage traffic.
- 1285.6 Concern was expressed that was the scheme measuring the right thing by way of data and could the local residents have an influence on that process.
- 1285.7 Comments were made that Elmstone Hardwicke had none of the traffic calming measures that Stoke Orchard had and were experiencing a huge volume of vehicles travelling at very high speeds. Adam Bunce said that they had been speaking with the Police to reduce the speed limit to 40mph subject to traffic surveys. There is evidence that there are more Commercial vehicles and artic units. Traffic modelling is updated on a regular basis.
- 1285.8 Concerns were expressed about the Pifs Elm junction and increase in the traffic volumes with queues forming and Adam Bunce assured the council that they were aware of that issue.
- 1285.9 The question was asked if the A4019 would remain open during the construction phase. Adam said that they intended to make the local roads more resilient before tacking the main junction. Any closures would be overnight closures
- 1285.10 It was confirmed that there would still be a footpath and cycle lane over the motorway.
